



Fig.2 Maximum Safe Operating Area





Fig.3 Normalized Transient Thermal Resistance vs. Pulse Width







Fig.6 Typical Output Characteristics(II)




## Fig.7 Breakdown Voltage vs. Junction Temperature

Drain - Source Voltage : V<sub>DS</sub> [V]









## Fig.8 Typical Transfer Characteristics

# Fig.10 Forward Transfer Admittance vs. Drain Current








Fig.11 Drain Current Derating Curve





Fig.13 Static Drain - Source On - State Resistance vs. Junction Temperature







Fig.14 Static Drain - Source On - State Resistance vs. Drain Current(I) Fig.15 Static Drain - Source On - State Resistance vs. Drain Current(II)

Fig.18 Switching Characteristics




Fig.19 Dynamic Input Characteristics






Fig.20 Source Current vs. Source Drain Voltage




